

PROJECT INTRODUCTION

Embracing Multimedia for Human Rights Education, is an international project organised and implemented by Youth Fors Society association from Albania, in collaboration with 7 partners associations from WB and Eu countries of the Eramsus+ programme.

The project AIMS to assist civil society organizations (CSOs) in

addressing human rights issues through education and creative tools. It promotes human rights education (HRE) and increase competences of youth workers and leaders on how




to work in practice, by using multimedia skills with young people from marginalized target groups.

Media is a strong tool to promote common values, to fight against racism and xenophobia and promote human rights, and this is the reason we used multimedia as a main pillar of the project. It is very important to work with the use of multimedia tools, especially to explore the concept of human rights, citizenship and promote participation of young people to be active citizen of our common Europe.

This project is a strategic initiative that provides a unique, flexible and secure approach to raising young people's awareness and capabilities. During the different activities the participants will be very much immersed into the issues of HRE, antidiscrimination and other related value-based topics. On the other hand, human rights protection remains an issue for most EU countries, especially new EU member states and countries in Europe's south (http://europa.eu/pol/rights/).

OBJECTIVES OF THE PROJECT

- develop competencies of youth workers/ leaders working with marginalized groups in key concepts of human rights education with young people
- ⇒ promote Compass manual and to familiarize the participants with its approaches and activities in order to use it and adapt in local realities.
- ⇒ to review and address essential knowledge, skills and attitudes for youth workers/activists working with disadvantaged target groups to offer to them practical tools how to work within HRE
- ⇒ promote InnoLab techniques, multimedia and non formal education among youth leader who are working with human right education for young people
- ⇒ use multimedia tools to promote human rights education for young people
- develop future partnership among youth workers/leaders in activity in order to set bridges of cooperation among experienced youth workers working in HRE
- ⇒ promote Erasmus +(Youth) programme as a tool for promoting young people rights and peer to peer education

ACTIVITY 1—TRAINING COURSE FOR YOUTH WORKERS

The training course on Human Rights Education, as first activity of the project "Embracing Multimedia for HRE" was implemented by Youth 4 Society organization and took place from 23-30 October 2015 in Tirana, Albania. The project was financed under KA 2, Capacity building in the field of youth, by European Commission, within Erasmus + Youth in Action Programme.

Partner countries: PEL- FYR of Macedonia, Ligo Lex Legis-Kosovo, Svetlost-Serbia, Praxis-UK, Group Zenith-Turkey, TDM 2000-Italy, Mladi Voluntari-Bosnia and Herzegovina.

Group: 32 participants (22 females and 10 males.)

Team: the training was facilitated from an international team of 4 trainers and 2 support staff.

It was designed as part of a long-term process, which allowed participants to explore the specificities of the non-formal and the formal education contexts in relation to human rights education. During the course participants got knowledge and tools to improve

their competencies in human rights education aiming that they will be able to prepare activities for disseminating the manual on human rights education and to implement and realize them after the training



with other young people. The training course gave to participants opportunity to discuss, learn and share their experiences working with young people with fewer opportunities in human rights education. The whole training course paid a particular attention to the concrete tools how to promote human rights education to young people, to foster critical thinking and to be tolerant toward differences, foster solidarity for the marginalized groups, sense of initiative and bring up new idea for the youth work. The workshops used in the training were taken from Compass – manual for youth workers on how to work in Human Rights Educations with young people. The learning-process during all training was based in Non formal education approach following the learning cycle of Kolb: Experience, Reflection, Generalization and

Application. The general methodology chosen by trainers was adapted to different learning styles/needs and participants were encouraged to participate actively getting out of their comfort zone. Trainers created a safe learning environment during whole activity, especially during the first days where they work to create the group cohesion. A great combination of tools were used (theoretical and practical tools) in order to encourage participants to discuss and bring their thoughts, ideas and generate solutions. Individual and team work, space for reflection and theoretical input from trainers team was provided. Different methods were used such as: brainstorming, buzz groups, video, simulation exercise, role play, debate, open group discussion, theatre, small working groups ect.







ACTIVITY 2 - TRAINING OF TRAINERS IN MULTIMEDIA AND HRE

The "Training of trainers on multimedia and promotion of HRE" was the second activity of the project implemented in Durres, Albania from 14-21 December 2015.

Partner countries: PEL- FYR of Macedonia, Ligo Lex Legis-Kosovo, Svetlost-Serbia, Praxis-UK, Group Zenith-Turkey, TDM 2000-Italy, Mladi Voluntari-Bosnia and Herzegovina.

Group: 24 participants (11 males and 13 females)

Team: the training was facilitated from an international team of 4 trainers and 2 support staff.

The main aim of this training course was to bring together 24 youth leaders/workers coming from different countries of Europe, in order to empower them with knowledge on promoting of human rights





education approach through multimedia tools, which they can use within their projects and practices. A core element of the training course was to foster young people from different cultural backgrounds in the strengthening of civil society providing them with practical tools how to use multimedia in their work as an innovative approach in promotion of human rights education. Combination of theory on HRE and practice in multimedia was an element which made this training course a very special experience. Participants got knowledge in human rights education main philosophy, multimedia, Erasmus + programme, networking.

As practical skills participants worked with multimedia tools such were: preparing the script, editing and sound, camera usage and adobe premier, written media and photography. At the end of the training the participants created 2 video jingles with message about importance of protection of human rights and inclusion in our communities. During the training course, participants were provided with knowledge and information about the historical role and present function of human rights, European institutions, the concepts and formal meanings, expressions of human rights education in concrete work with youngsters with fewer opportunities. Both the Council of Europe and the European Commission are promoting active citizenship and human rights education through policies and programs and therefore detailed presentations were done by the trainers.

Project was a unique and sucesfull experience because practice and thoery was combined in useful way. During the first days of training participants got knowledge in key concepts such were: human rights, human rights education approach, inclusion, equality, citizenship, intercultural learning, solidarity, empathy, Erasmus +Youth in Action etc. In continuation participants worked with multimedia tools participating in different workshops such as: photograpy, written media, articles, sound, figure, editing etc. Participants improved their competencies as trainers in human rights educationan and inclusion topic and learn practically how to use multimedia in their youth work with young people.





ACTIVITY 3—YOUTH EXCHANGE

The youth exchange "Act for Human Rights Education" was the third activity of the project implemented in Pogradec, Albania from 10-18 March 2016.

Partner countries: PEL- FYR of Macedonia, Ligo Lex Legis-Kosovo, Svetlost-Serbia, Praxis-UK, Group Zenith-Turkey, TDM 2000-Italy, Mladi Voluntari-Bosnia and Herzegovina.

Group: 40 participants and group leaders (25 males and 15 females) **Team**: The exchange was facilitated by group leaders ammd 2 support staff.

The main aim of the exchange was to allow the young people come together in a multicultural environment and learn about human rights and multimedia tools that an be used to advacate the HRE.

At same time the main focus of the project was that participants that were in the first two activities would lead the groups and have

the possibility to firstly practice the skills and knowledge gained in the TCs, and secondly transfer these skills to the other participants.

The youth exchange was run through the non formal education settings, allowing the participants to get the neccesary skills and knowledge and to put

them in practice.

As such, during the event concrete workshops from HRE manuals were impleneted, role plays and imulation activities, as well as country realities. All these gave the partiicpants the possibility to learn more about HRE and each others reality they come from.



The second half of the exchange was then fully based on putting skills in practice. Learning from professionals of vidoe making and media approaches, they were able to learn how to edit and produce short videos, always focusing on uman rights issues. As an added element to the exchange was the focus in written media, where they were taught how to write reportage and articles for online media.

After working in groups the participants created 4 different works that were later on exhibited in an open exhibition at the hotel where some local youngsters and media chanels were invited to participate. The 4 worksh were:

- Photo reportage about gender based issues "You know my gender not my story- Gender in-between the stereotypes!"
- Article and street interviews about the city of Pogradec
- Photo reportage about gender equality Violence is not the choice
- Photo reportage "the right to choose", with pictures taken from the creatins of recycled materials and pictures using shadows technique

Its to be emphasized that the work done from the groups was exceptional, with lots of collaboration and creativity to apply all the information, knowledge and skills received in the previous two trainings

Follow up by PEL-FYR of Macedonia

Between 1st of May and 1st of July 2016, Association for Progress, Education and Lobbying PEL was implementing a campaign under the motto "Embracing Multimedia for HRE" in city of Skopje. Initial idea of the campaign was a result of participants follow up local campaign who attended trainings and youth exchange within the same project in Albania.

Main Aims

Main aim of this campaign was to raise the awareness about the concept of Human rights, European citizenship and rights of the European citizens to the local people of Skopje. Another aim of the campaign was to increase the motivation of people for active usage of EU opportunities in area of mobility, jobs and job market. Furthermore, with this campaign we wanted to raise the awareness about EU particularly in the context of the equality, integration, a general rise in anti-immigrant sentiment and xenophobia.

Additionally, our aim was to collect the opinion of citizens on some of key European challenges for the future, focusing mainly on active European Citizenship and new institutional developments.

Campaign contained two different activities and approaches.

Use of Media in HRE

The first activity/workshop was made with two respective journalists from Macedonia having a minority background where we wanted to catch the attention of the local young people about the use of media concerning human rights, presentation of the same in the public,

equality and how does it feel to be a journalist with a minority back-ground. This workshop was held on 21st May 2016 in the garden of "Get In Hostel" Skopje with 15 participants.



Human Rights workshop

Afterwards, 22nd of May 2016 we organized workshop with local youngsters where they had an opportunity to learn more about Human Rights, history and policies through info materials. We had concrete workshops about violation of human rights, the right to live, freedom of expression, the right to get married, etc. This workshop that had 4 working sessions, was held at the Faculty of Philology Blaze Koneski Skopje with 30 participants.

With our actions we wanted to spread more knowledge about the HR, or at the ground level – to introduce the valid sources of information about the HR and proper channels of communication for further involvement of the citizens in order to have their rights respected.

Target Group

Target group of this campaign was whole civil local society of Skopje over 15 years old. We did not want to limit our campaign to a particular age group because our leading taught was that Skopje needs a systematic change on every level. Therefore, we tried to influence youth, middle aged as well as the older citizens.

Follow up by Mladi Volonteri-BiH

Under the project Embracing Multimedia for HRE, the participants of our partner from Bosnia and Herzegovina organized a local workshop with young people. The main aim of the workshop was to present the outcomes of the activity, as a tool raise awareness among youth about human rights issues and also boost their curiosity and interest to participate in Erasmus + Youth in Action

The local youngsters had a chance to hear the experience of the participants and also ask questions to them. The workshop was concluded with showing the videos produced during the project in Albania and a focus was put on how the local youth can use multimedia tools to pro-

mote human rights education and to raise

awareness.

As a second step of the follow up the participants had prepare some leaflets about the organization and the work with HRE and distributed them in local community among different people.

Follow up by Ligo Lex Legis-Kosovo

Ligo Lex Legis used the project results and the participants experience to disseminate them during 3 different seminars in Prishtina. The association is a Contact Point for Erasmus+ Youth in Action in Kosovo, and during 3 seminars to inform associations and youngsters about E+, they used the experience of the participants of our project. They had a chance to talk about the project, show pictures and videos as well as share questions and answers with the participants of these seminars.

Follow up by Svetlost — Serbia

Our Serbian partner used the experience gained through the project to organizes a workshop with teenagers and speak about Human Rights Education and its importance. The workshop organized in their offices gathered a group of local teenagers and together they implemented a half day training based on non formal education and human rights issues with youngsters. The workshop aimed at raising the awareness

of the youngsters towards being tolerant and respectful towards other cultures and backgrounds, advocating about human rights, and giving youngsters a space to share their ideas and feelings.

It was particularly interesting the interaction between them and the curiosity to know more about the no formal learning approaches used during the workshop. Videos and pictures of the project were also shown to them in order to initiate discussion and debate on why is it important to promote human rights and learn how to respect them





Through the photos we showed the ability of taking decisions of what we want to do, such as where to work, what to study, with whom to spend the life, etc. but also, using shadows as forces, we showed how a person feels when someone forces him/her to make some choice. There is a photo where a shadow forces a girl to make a choice; that shadow represents small group of people who forces us to make some choice, like family, friends, boyfriend/girlfriend, teacher, etc. On the other photo we have more shadows which represent bigger groups such as the society, culture, religion, etc. Also we showed a girl with just one option "to choose": the message is that if you have only one option, it doesn't mean that you can choose; you have not the ability to choose in such cases. We showed a girl writing her own choices: that is the real freedom to choose! At the very end, we showed that in some countries the freedom of making choices by ourselves is bigger, in some is smaller, but for sure no one's rights are guaranteed, so spread messages among your friends in order to raise an awareness about the importance of the implementation of human rights!



The NGO has 2 different offices were volunteers and the board work on daily basis. The group is composed by 800 members that actively participate in the projects of the NGO. TDM 2000 is accredited to host, send and coordinate volunteers in the frame of EVS. We are recognized as volunteer organization by the Sardinian Regional Government. We are registered by the CoE and we participate in Leonardo Da Vinci Program. From 2009 we are hosting a project under National Civil Service. In 2010 TDM 2000 signed a partnership with University of Cagliari for the recognition of non formal learning and the attribution of credits. We also signed a similar agreement with "ENTE ERSU" the public institution that is entitled to give scholarship and housing for university students.

Associazione TDM 2000 is member of TDM 2000 International network and Anna Lindh Foundation network. Our organization has a

lot of experience on the main topic of this application, Human Rights. We have implemented several projects under the old programmes of "Youth" and "Youth in Action". Furthermore, we are also partners in projects that tackle topics as human rights for children and other target groups, in order to protect fewer opportunities people and other marginalized groups.
